El Segundo to Welcome Special Olympics Athletes Next Week

The local community will have several opportunities to meet the group of about 70 athletes and coaches visiting next week as El Segundo assumes the role of a Host Town for the upcoming Special Olympics World Games taking place in Los Angeles. Teams from Barbados and Macedonia will spend portions of three days in El Segundo taking part in various events, recreational activities and cultural exchange. While still subject to change, here was the itinerary as of this writing:

The El Segundo festivities will officially kick off on Tuesday, July 21 with a torch run on the lawn in front of Mattel at 5:05. The public is invited to experience seeing the Special Olympics Torch. After the brief ceremony that will also include a presentation, cookies, and an appearance by Los Angeles Kings' mascot Bailey and accompanying Ice Crew, the delegation will take a short trip to the LDS Church for a private, hosted dinner which is also part of the local Eagle Scout project for Gavin Lueck from Troop 772.

After breakfast and exercise at Loyola Marymount University (where the athletes and support staff will stay overnight in dorms) the following morning, the visitors will head to the Automobile Driving Museum for a noon tour that will feature an appearance by Herbie "The Love Bug." Next, the group will proceed to Old Town Music Hall for a

2 p.m. showing with popcorn/refreshments. After a walk down Main Street, the delegation will pose for a photo in front of El Segundo High School at approximately 3:45 p.m. The day will wrap up at Chevron Park with a barbecue hosted by local police and fire personnel, who will cook up burgers, hot dogs and chicken. The community is invited to meet the athletes after dinner between 6 and 8 p.m. when there will be games and live music (by Northrop Grumman Aerospace

Corporation's Hornet Nation band).

The activities for Thursday, July 23 will include a trek to the Toyota Sports Center, where the group will have lunch at the Kings Cove restaurant at 1 p.m. A tour of the Kings and Los Angeles Lakers' facilities will follow. Athletes will also enjoy some ice time--and there were talks about arranging a street hockey clinic in front of the venue. At 4 p.m., the crew will arrive at the

School Board Announces Winning Bid for Imperial Ave. Property

The El Segundo Unified School District School Board Tuesday night accepted the bid of builder D.R. Horton for the 5.66 acres of School District owned land located at 540 E. Imperial Avenue. The winning bid was for \$22,625,000. The currently unoccupied elementary school on the land was constructed in 1956, but was closed due to declining enrollment in 1975. In 1984, the site was utilized as an employee training site for Hughes Aircraft employees. In 1995, the school was re-opened and leased to the Los Angeles Unified School District as a special needs

school, but was closed a few years later.

In 2008, the District passed a resolution receiving recommendations from an Advisory Committee for the disposition of the land that was deemed surplus in 1979. One of the Advisory Committee recommendations was to lease the majority of the property for assisted living/ and or senior housing. The District held meetings about the feasibility of the lease option, and began the process of getting the land entitled for future development.

There are two current scenarios in play for the development of the property. The

Feels Bill is Excessive and Unnecessary

June 6, I made an emergency 911 call, for my mother. The paramedics arrived, then paramedics transported her to the emergency room at Marina Del Rey, 5.3 miles away. She was treated and is now doing fine, until July 3. She received a bill from the City of El Segundo, with a Sacramento address, demanding \$1,853.75 "for services".

It turns out this is an agency hired by El Segundo to collect money for services for transporting her, an El Segundo resident, in an El Segundo city vehicle, by El Segundo City paramedics and that she is responsible for that bill in full.

I brought this up at the 7/7/2015 council meeting. After a discussion with the Fire Chief, he stated this is now the policy in El Segundo,

to bill the residences/taxpayers of El Segundo for services by El Segundo paramedics, using El Segundo City equipment, even though the taxpayers of this city continually pay for both.

There are seniors here, on a fixed income, who don't even make half of \$1,853.75 in a month. This collection is not only excessive, but unnecessary.

I find it offensive that our residence/taxpayers who paid, in 2014, firefighter salaries who make between \$100,000 to \$285,000, that are supplied with multimillion dollar vehicles and the best equipment, that now these same taxpayers will have to pay extra for a service by city employees to do the job they were hired for in the first place.

Something has to change now.

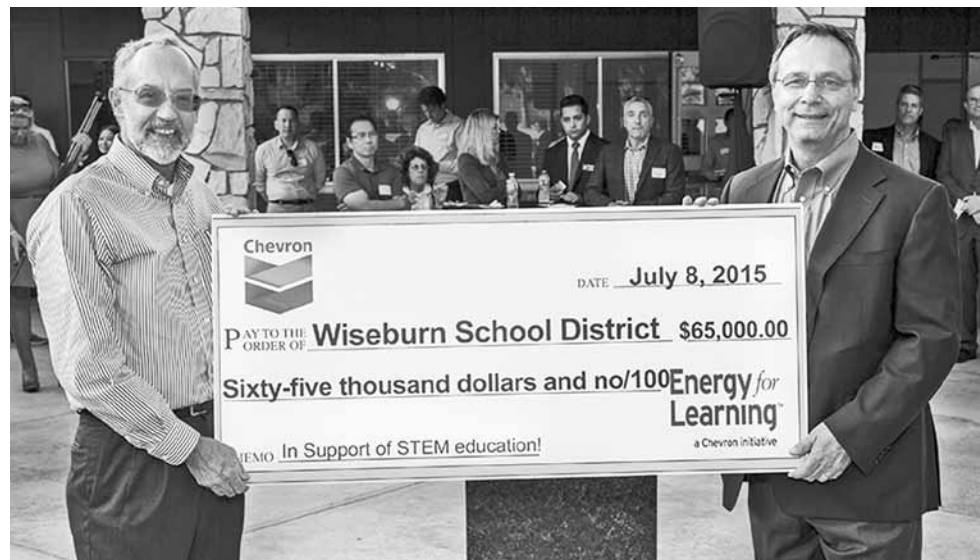


Chevron Announces \$1.3 Million Investment in South Bay Schools

Like Father, Like Son: Kirk Brown Realty Gets Back to Its Roots

When it comes to maintaining a family business, more than a few dads out there dream that their sons will “follow in the old man’s footsteps.” In the case of long-time local broker/realtor Kirk Brown, Sr., he opted to not play his hand despite harboring unspoken hopes about his own progeny. “I did one thing that was smart—I never asked my son, ‘Why don’t you come into real estate?’” he said. The decision to steer clear of any semblance of pressure tactics proved to be the ideal reverse psychology. In 2002, then 22-year-old recent USC graduate Kirk Brown, Jr. had tired of working in the film industry and approached his father one morning: “What would you think if I tried real estate?” the younger Brown asked. “If you think that’s something you’d be interested in doing, then it’s up to you,” the older Brown responded stoically, while secretly doing cartwheels inside.

Thirteen years later, the father/son duo continues to thrive as equal partners providing real estate and property management services to hundreds of clients. But after many years under the moniker of Main Street Realty, the two decided to go back to their roots and rename the company Kirk Brown Realty. “The name change is reflective of who we are and what we do,” Kirk, Jr said. “It’s just the two Kirks and there are no other agents.”

The Brown family goes back five generations in El Segundo, arriving here in 1924 with a patriarch who became a higher-up in the Police Department. Kirk Brown, Sr., whose father Wilson worked at Standard Oil for 40 years, was a gifted athlete and member of El Segundo High School’s only CIF championship basketball squad back in 1963. He eventually went into teaching, even leaving the community for seven years to work at Alhambra High School. Always restless and looking for a new challenge, he also earned

his real estate license during that period and worked part-time in the summers. “I found out I could do it [real estate] and liked it,” he said of the experience. “Then one day I got a call from my former basketball coach, Cliff Warren—who had helped build all the Shorewood Realtors offices. He had retired, but heard I had gotten my license and asked if I would come talk to him.”

The chat with Warren led to a five-year job working for his old coach and a move back to El Segundo. After the apprenticeship, Kirk, Sr. opened the original Kirk Brown Realty at 429 E. Grand Avenue in 1980. Wanting to be in the thick of things in the middle of downtown, he eventually rented a building at the corner of Main Street and Holly Avenue owned at the time by the late realtor and former Herald Publications board member Marie Stinnett. “In 1989, I was able to buy the property and did a tear-down so I could rebuild it,” Kirk, Sr. said. He continued to operate under his own name for a few more years, but then rented the building to Re/Max for a spell. “After I left Re/Max, I ended up having 10 agents working for me—so I changed the business name to Main Street Realty.”

Time and changes in the industry ultimately whittled down the number of agents and so it has just been father and son for the last few years. “It was a natural switch to go back to the original name,” Kirk, Sr. said. “Plus, a lot of people in town still called it Kirk Brown Realty even though the name had changed.”

Now 70 and a veteran of over 35 years in the real estate wars, Kirk, Sr. admits that he has been rejuvenated by his son’s presence in the company. “I feel so fortunate that I get to come in the office every day where a great kid is—a kid who happens to be my son,” he said. “He is as honest and open as the day is long and is really a quality guy.”

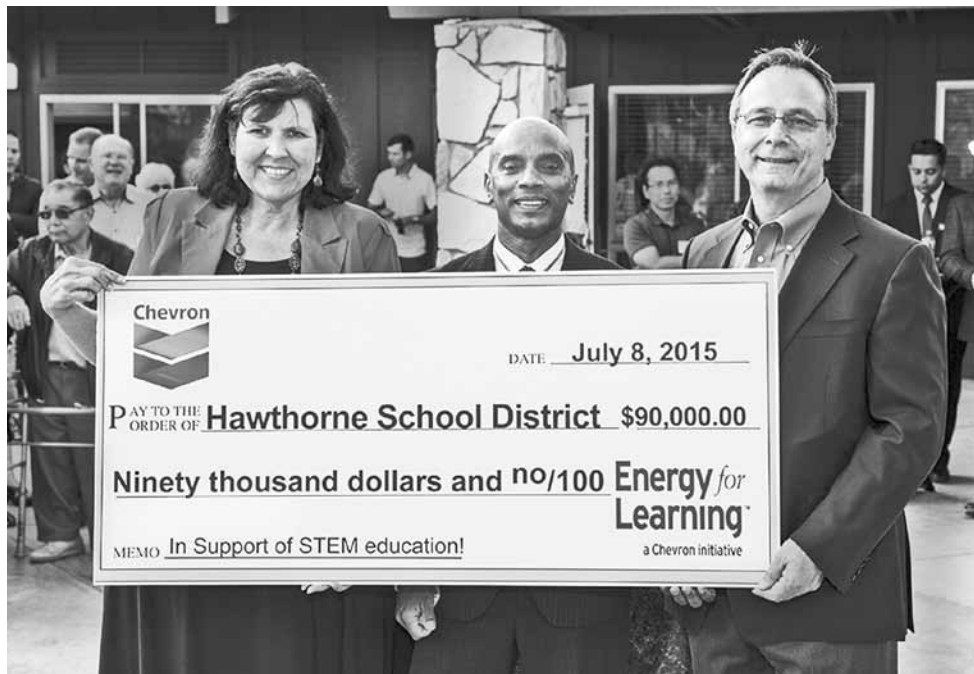

Grape-a-licious Fro-Yo Mini Pies



Makes 12 mini-pies

Ingredients

- 1/2 cup grape juice concentrate (divided use)
- 1 tablespoon lemon juice
- 1 1/2 cups California grapes
- 1 tablespoon corn starch
- 2 tablespoons unsalted butter, melted
- 1 cup graham cracker crumbs (about 9 squares)
- 3 1/2 ounces vanilla frozen yogurt (softened)
- Frozen grape clusters for garnish
- Lemon slices (optional garnish)

Preparation

1. Preheat the oven to 350 F. Line 12 muffin tins with foil cup liners and set aside.
2. In a small bowl, mix the graham cracker crumbs with the butter. Place 1 tablespoon of the graham cracker mixture into each muffin cup and gently press to form a crust in the baking cups. Bake for seven minutes; set aside.
3. Combine 1/4 cup of the grape juice concentrate, lemon juice, and grapes in a small sauce pan over medium heat. Meanwhile combine the remaining grape juice with corn starch and mix well, then add to the sauce pan. Bring the mixture to a boil for one to two minutes until thick. Allow to cool. Once this mixture cools, pour into a blender and blend until smooth. Add the softened yogurt and blend for a few pulses until just combined.
4. Place about 4 tablespoons of the grape-yogurt mixture into each muffin tin. Place in the freezer for four hours or more. Serve with small clusters of frozen grapes and enjoy.

Lakers' Future Shines Bright

For three straight years now the summer has been a disappointment for the Los Angeles Lakers. Going into the offseason with money in their pockets and as huge players on the free-agent market, Mitch Kupchak and the rest of the Lakers front office have dangled dollar signs and trophies in front of the best players on the market only to walk back home empty handed at the end of the day. This offseason was no different. As LaMarcus Aldridge, Kevin Love, DeAndre Jordan and many other of this year's best free-agents signed elsewhere, the Lakers stood pat and looked on like a young child on Christmas Day who received nothing but socks and underwear. Christmas Day may not have looked good for the Lakers at first glance, but those socks and underwear are going to pave the way for a toy chest full of surprises in the off-seasons to come.

While many Laker fans have been left disappointed and with questions on their minds, Kupchak remains focused and levelheaded. "No, not at all. It wasn't demoralizing," the Lakers GM said of his team's free agency period. "It's part of doing business. There are 30 very, very competitive NBA teams. All general managers are smart. Finishing at 21-61 in the standings, if the Lakers don't begin to get better now, then there is serious cause for concern in Hollywood. The players that the Lakers acquired in this June's draft may just be the team's key to future success, however, and may just bring "Showtime" back to the Staples Center.

The most notable acquisition is former Ohio State guard and second overall pick

Film Review

Woody Allen's *Irrational Man* is a Philosophically Thin Whiff

It's no surprise that a Woody Allen picture, while adding to the auteur's critically acclaimed filmography, also effectively serves as the writer/director's own version of self-therapy. Wrapped up in the comic absurdities of his largely light-hearted fare are still the obsessions of primal, and darker nature.

In his latest picture, *Irrational Man*, Allen chews over the theme of murder, but more so of the self-fulfillment found when acting on our impulses that make us all-too-human. However, as has trended in his recent films, this outing is a one-note exercise that is an unfortunate mix of what can make a Woody Allen film so bad: a boring dud that reveals an obvious perverseness to the whole show.

With *Irrational Man*, Allen is yet again out to stew on a subject of familiar curiosity—philosophy, and here, of the existential enlightenment and happiness fulfillment that can reawaken even the most cynical of intellectuals, as acted out by a simple measure of following your darkest “id” desires (while it's not entirely relevant, it wouldn't take a professional to perform an arguably sound psychoanalysis that tracks along his divisive more media-storied personal life).

Irrational Man stars Joaquin Phoenix as Abe Lucas, a tormented philosophy professor whose arrival to teach at a small east coast university excites everyone—except his spiritually and emotionally bankrupt self. That is, until a random coincidence presents itself (I'll refrain from explaining further, in what serves as the story's central plot), to which the broody cynic finds newfound happiness and purpose in acting upon.

The movie opens, after the auteur's signature black title card opening credits, with our meeting of Abe, but through the campus buzz and chatter of giddy students and faculty alike waxing adorations over his undeniably alluring mystery and dangerous and romantic intelligence. Clearly, we are supposed to like this mysteriously tortured artist character before we even meet him. This, as we learn soon enough, reveals the empty logic that makes up this rather irritatingly unmotivated exercise, and will make *Irrational Man* another recent Woody whiff.

Much needed cinematic support comes in the form of the new women in Abe's life, and it mostly takes advantage of those pieces, however eye-rolling they may be. Emma Stone makes her sophomore appearance in an Allen

film, after her turn as an alluring young medium in last year's *Magic in the Moonlight*, and who once again channels her beam of sunshine radiance into making googly-eyes at another older male love interest. Stone as undergraduate Jill, whose early crush on the intellectual celebrity turns into a rather more consuming attraction, and much to the

dismay of undergrad boyfriend Roy (Jamie Blackley), is always a joy onscreen, and her Jill ultimately becomes the hero of another story altogether.

The sexy basket-case and fellow professor Rita (Parker Posey) serves as the more dominating damsel in Abe's life, whose equal interest in the newly brought aboard professor elicit casual affairs. With hardly enough good writing here to substantiate the desirability of “Abe Lucas” for these lovelorn women, the whole show feels emptier and more vapid than it possibly even should.

And then there's the self-tortured artist himself, whose own self-important frustrations serve as the gravitational center to this universe. If the writing, which feels like a first pass of a script at best, is the clunkiest thing here, then the casting of Phoenix is next in line as to understanding what doesn't work.

Abe, as played by a rather dull Joaquin Phoenix, appears to be a character cut more directly from Allen's own bank of canonical Woody-types that are his characters, but his lock-jawed delivery and overall burnout moroseness fail to create anything besides a sense of dangerous mystery to the character, and especially not a whiff of a comedic sell which may have saved the film in most ways. The fact that Abe is so un-funnily depressed in the film's first half, and then so un-funnily not depressed after the inciting incident in the film's second half, is what may stand as the biggest problem from what makes this movie work.

It may go to reason that, of the writer/director's entire filmography, of which he makes and releases a film a year, not every one of the seventy-nine year-old neurotic's projects are going to be hits. And while no parties here will carry these demerits with them (including Allen himself), *Irrational Man* may serve as the most unexpected entry into lazier storytelling, revealing more perverse discomfort and acknowledgment in a Woody Allen movie than we may be used to.

Irrational Man opens this Friday at ArcLight Beach Cities and other select theaters. •

Do You Know What Will Happen If You Don't Make a Will In California?

In some parts of the U.S., like West Virginia, if you die without a will, your estate is first distributed according to your marital status and children, including those of previous marriages. However, if you have no spouse or children, you may want to pull out your family tree to see who could be in the running.

When there is no will in place, commonly in West Virginia, the current spouse of a married couple with or without one or more descendants receives the full estate. However, your spouse would receive only 60% of the estate if he or she had children with you and also a previous marriage. Your children would then receive the remaining 40% of the estate. But if you were the spouse with kids from a previous marriage(s), then all your children will inherit one-half of your estate, and the other half to your current spouse.

Confused yet? That's what The (Huntington, WV) Herald-Dispatch asks us in its recent article titled “*Planning ahead: What happens if you don't have a will.*”

If you don't have a surviving spouse, your estate will be divided among your descendants (children, grandchildren, nieces and nephews...). If you don't have any descendants,

it will be inherited in this order:

1. your parents;
2. your brothers and sisters;
3. nephews and nieces;
4. grandparents or their descendants; and then finally,
5. the State.

So if your parents are alive, they get it all. No one in the later groups will receive anything.

That's the basic structure of intestacy, which means “without a will.”

In intestacy, there are no special provisions to cover unique situations, no gifts to favorite non-profit organizations, and no special strategies to lower estate taxes.

Intestacy can be the most expensive version of estate “planning.”

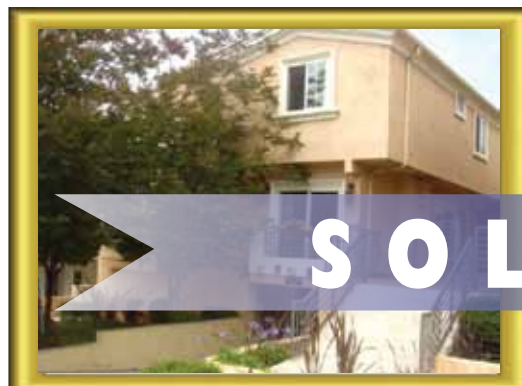

The admiration goes both ways. Kirk, Jr. chose his father to be the best man at his wedding over several close friends. "We work together really well," Kirk, Jr., who is also a broker like his pop, said. "We have two companies [Kirk Brown Realty and Kirk Brown Property Management] and a lot of properties to oversee. We need to rely on each other to split up the work."

Asked what the most important trait they have learned from one another is, Kirk, Sr. immediately chimed in, "Patience..." His son replied, "Drive..." And despite different points of view at times, there are no squabbles. "Inside or outside of the office, we treat each other with respect," Kirk, Sr. said. He added that the respect extends to clients and is a pivotal part of the team's business success. "We're going to be here tomorrow. How do you do that? Treat people right. That also includes our fellow realtors in town. There are a number of good ones here and we help each other out because it's a win-win for everyone. There's enough business to go around."

Not only is there seemingly enough business nowadays, but El Segundo real estate has reached its all-time pinnacle. "Prices have never been so high in the history of our town," Kirk, Sr. said. "El Segundo is hot." Asked what has prompted the major jump in property valuations, he pointed to continued low interest rates, a great school system, and prices still considerably lower than Manhattan Beach. The combination has resulted in many very happy (and pleasantly surprised) new residents. "The fun part of our job is being with the clients—many of

whom have become our friends--and getting to meet new people," Kirk, Jr. said. "It's really rewarding to sell someone their first house or increase the value of their property that we manage. I'm excited by what's happening in real estate in town."

Real estate in town has certainly changed over the years. Kirk, Sr. recalls that when he started out, a typical transaction only required a single, one-sided 8.5 x 11 sheet and has since grown to over 40 pages of detailed paperwork. And the agent himself is also admittedly a tad greyer. "When I first sold real estate here, I was always the youngest guy in every meeting--now I'm the oldest guy," Kirk, Sr. said. But he has no plans to retire anytime soon. "They'll have to carry me out of here."

Both Kirks plan to remain in El Segundo for the long haul to continue the local family line of Browns. Kirk, Jr. has a two-year-old son daughter (Clara) and a 10-month-old son (Wilson Kirk). Union Activism

The firefighter and police officer "associations" are labor unions. They spent thousands of dollars campaigning for a month, with deceptive campaign ads and mailers, to keep millions of dollars per year in excess compensation they receive as rewards for their support for past City Council candidates.

None of the firefighters and only one fourth of the police live in town. They want to control and run our city for their own financial benefit.

Their unions exist to continuously increase their compensation, no matter how excessive and unsustainable, at our expense in money and safety. They support candidates and ballot measures that will maximize their pay, and raise our taxes and fees to pay for it.

For example, the firefighters put Measure P on the 4/10/2012 ballot to maximize their compensation, but reduce our safety. It would have forced El Segundo to contract with the L.A. County Fire Department for an inferior level of service. We would have lost our three paramedic transport ambulances, and been forced to use out-of-town ambulance companies, doubling hospital transport times. The firefighters hired a campaign consultant, election lawyers, and professional pollsters. They probably spent over \$100,000. I led the grassroots campaign against Measure P. Thankfully, 90% of voters voted "No".

The city unions contributed \$17,500 to the Measure A campaign (4/8/2014). Measure A was eleven tax hikes in one measure, on residents and businesses. I led the campaign against Measure A. We won again.

Worried About Repercussions

The ES Public Safety Unions compensation contracts are being discussed by the City Council. I'm not here to argue for or against what the Unions are asking for, but most Public Safety Union members pay and benefits seem fairly generous.

Recently, I discovered many ES residents will not express their point of view about Public Safety employee's compensation in public if they are not in support of raises.

Why? Many are concerned about possible repercussions. I understand those concerns.

Several years ago I spoke at a City Council meeting. I assumed the council was the right place to ask for some added enforcement for traffic safety. I was wrong.

Several days later, I received a call from an ESPD officer I knew on a personal level. I was told that I had embarrassed the department, and warned to look out for tickets for offences I don't recall doing! Like parking near a fire hydrant or in a handicap spot — tickets that cost many \$100's of dollars in fines! I was shocked... and intimidated.

I never received a surprise ticket, but it changed me. What was communicated to me was clearly illegal. But it works. If someone speaks publically against Public Safety Union contracts or matters, will they get a parking or speeding ticket for something they did not do? It's intimidating to know the union members have that power.

We live in a very small town, and there are many citizens of El Segundo who feel this way - Intimidated. — Robert Clark •

"The lifeguards are falling all over themselves to volunteer," said Los Angeles County Lifeguard Association executive board member Arthur Verge, who was pleased by the willingness of so many personnel to help out. As of this writing, the effort was still more than \$15,000 short of the required funds--about \$30,000 in all--to cover the costs of lodging, food, transportation and other incidentals (which in El Segundo's case includes banners along Main Street, "swag" bags for each athlete, t-shirts for the volunteers and other items) that a Host Town must subsidize, but organizers remained confident about pulling in the additional monies. The list of major sponsors was not complete as of press time, but organizers indicated they will provide a full rundown in the coming weeks.

Earlier fundraising events at The Lakes at El Segundo, The Tavern on Main, Moto Art and Library Park helped the cause, with additional programs scheduled on Friday, July 17 at Second City Bistro (a jazz dinner

featuring the Jesse Bradley Trio from 7 to 10 during which 20 percent of tabs with coupons presented will be donated) and Saturday, July 18 at the Purple Orchid (live music from surf band CHUM, with 20 percent of all sales between 3 and 7 donated). Meanwhile, individuals and businesses can still make direct donations online at ww.la2015.org/host-town/elsegundo, or sign up to volunteer by emailing eshosttown@gmail.com.

As for the athletes themselves, the vast majority are between the ages of 15 and 30, with the youngest in the El Segundo delegation an 11-year-old and the oldest 48--though there is no set age limit. They will represent their countries in the sports of aquatics, athletics/track & field, badminton, basketball, bocce, football/soccer, golf, gymnastics (artistic/rhythmic), and table tennis.

Of the total El Segundo visitors, 43 are from Barbados (an English-speaking country) with 26 from Macedonia. The athletes make up 80 percent of the group, with one coach or staff member per every four athletes. The 2015 Special Olympics World Games will run between July 25 and August 7, with 7,000 athletes and 3,000 coaches from 177 countries participating. Opening ceremonies will take place at the Los Angeles Memorial Coliseum (the site of the 1932 and 1984 Olympic Games) with a number of Southland venues hosting various events. With more than 30,000 volunteers and a half a million spectators expected, the Special Olympic World Games will be the largest sporting event of its kind in the world this year and will even exceed the 1984 Olympics in scope.

"This benefits not only the athletes, but brings awareness to all of us that people with mental and physical difficulties can overcome adversity," said El Segundo City Councilmember Dave Atkinson. "We are proud to be a Host Town and hope the community comes out in large numbers during the events to support these amazing athletes. It'll be an experience none of us will ever forget." •

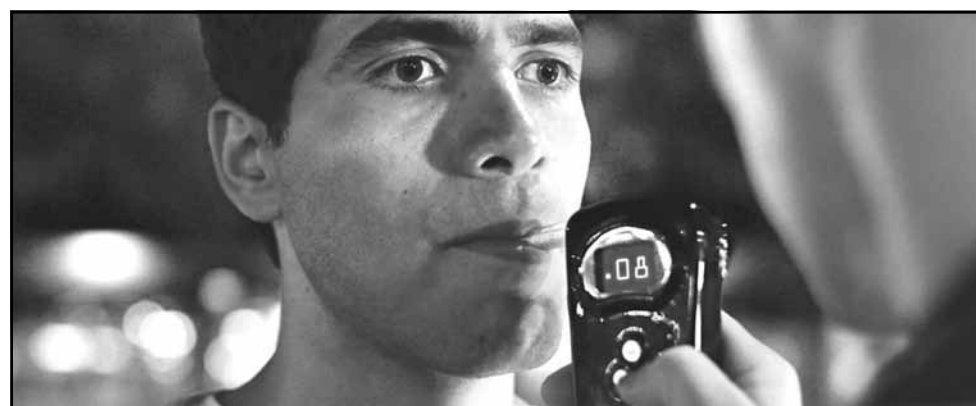
D'Angelo Russell. Russell has already proven at Ohio State and to a certain extent so far in the Lakers Summer League that he can get his teammates the basketball. Over time, he may become a prolific scorer as well, but Russell is already proving that he has what it takes to make players around him better. "It's going to be fun," he said smiling. "We can have a pretty scary backcourt."

Russell's backcourt mate is another youngster, Jordan Clarkson. In his first two summer league games, Clarkson compiled a total of 42 points. At age 23, Clarkson and a 19-year-old Russell will form one of the youngest yet one of the potentially scariest and most explosive backcourts in the league if all plays out how it is supposed to. Throw a healthy Julius Randle and Kobe Bryant into the mix and the Lakers could be on to something. Health, of course, is the key with this team, but with the nucleus that is forming on the court in Los Angeles, you can see the cause for excitement surrounding the Lakers. "I don't see why we don't contend for a playoff spot," Kupchak said. "But our young players have to grow beyond their years, and we have to stay healthy."

Along with Clarkson, Russell, and Randle, there are various other young players to watch on the Lakers as well. Most notably, Robert Upshaw, Larry Nance Jr., and Anthony Brown. Upshaw could really turn out to be

something special if he keeps his head on straight, but to add to the youngsters, the Lakers have also brought in Roy Hibbert, the reigning NBA Sixth Man of the year Lou Williams, and Brandon Bass. Those moves aren't getting the Lakers a championship, but they are great, smaller moves made on short-term contracts that will help to develop the younger players on the team. Next season, Kobe's contract will come off the books and the Lakers will once again have all of the money in the world to (attempt) to spend on the free-agent market.

No one ever said that the Lakers were going to be championship contenders overnight. The process of rebuilding is always a long and drawn-out process, the hope was just that the Lakers could do it in a more timely fashion than other teams. This year is a year for the youngsters on the Lakers to come out and prove themselves to the rest of the league. Don't expect a championship, simply expect some fun and exciting play from a new, young group of core talent. If this year's Lakers can prove that they can play in the NBA, expect to get the rest of the league's attention. Once that happens, players will flock to Los Angeles in free-agency like they used to and in a year or two, the Los Angeles Lakers will be back on top of the Western Conference vying for more championship trophies to add to the shelf. •

SUMMARY OF ADOPTED URGENCY ORDINANCE:

Amending ESMC Chapter 10-5 to inact permanent water conservation measures and requirements. The urgency ordinance is intended to comply with Governor Brown's Executive Order B-29-15 declaring a drought and emergency regulations promulgated by the California State Water Resources Control Board. The urgency ordinance continues and modifies existing potable water use prohibitions, adds new potable water use prohibitions, adds water rationing requirements, and adds penalties. Compliance with the urgency ordinance would be mandatory, unless the use of water is required by a state or federal permit, or otherwise exempt.

and to an occupational therapist who worked with her at USC Norris Hospital after her brain surgery. During these trips she was the one consoling those she encountered including nurses and doctors. Throughout her life she befriended those who were left out or lonely or those who were hurting. She was a magnet for young children who gazed and stared at her and she responded by getting on the floor and playing with them.

Lizzy learned some very valuable lessons at an early age by a stranger invited into her home. It is these quality traits that she lived by and helps build the foundation and criteria for recipients of the Lizzy Garland Scholarship Award.

As Lizzy's father describes, he met a homeless man down on his luck without sobriety for years and invited him to stay with his family. It would be this connection with the Garland family and

especially Lizzy that would forever be a changing moment in all of their lives. The family took in Dennis McCarthy, who would sleep on the family's couch off and on for several years.

Lizzy wrote about her experience growing up with the man she would come to call Uncle Dennis. Though McCarthy credits the Garlands

with turning his life around, Lizzy wrote that Uncle Dennis taught her much more than her family ever gave him. Currently, McCarthy is married, owns his own home and owns his own construction company.

"Uncle Dennis taught me some precious life lessons. He taught me to give people

a second chance when society turns them away. He provided a great example for everyone to never lose hope and through persistence we can accomplish more than we originally thought. Lastly, he taught me to be thankful for everything I have and to love everyone even if at first it may seem an impossible task."

Lizzy's uniform number #16 has been retired and a plaque displaying her number is exhibited in the outfield before each game. It is a reminder to current and future players what she meant to the team, the school and her community.

What a wonderful world it was with Lizzy

Garland in it. Though she's playing third base for the Angels now she lives through the recipients of the scholarship named in her honor.

The Lizzy Garland Scholarship Award was spearheaded by Coach Cameron who thought it was the poignant idea to honor Lizzy and her attributes as a team player and person. The first recipient who exemplified what Lizzy stood for was Linea Palmer. This year there were four seniors Kaitlin Covington, Katherine Burner, Shannon Brooker, and Rhianna Rich, who embodied the spirit of the award.

first scenario would divide the property into two parcels. The larger of the two parcels would be dedicated to senior housing, both apartments (150) and assisted living units (150). The second, much smaller parcel, would be developed with four townhomes.

While representatives of the City of El Segundo favor scenario one, a second option would include the construction of 58 single and multi-family residences.

In June of 2010, the Board had entered into an agreement with Mar Ventures, Inc. to have the property entitled to be developed as a senior housing community with a multi-family residential component. At that time, the District favored securing a long-term lease agreement instead of an outright sale. But the District was unsuccessful in finalizing a transaction with any interested parties, and decided last summer to ask the Department of Education for a waiver of the competitive bid requirements to lease the property. The Department of Education granted the waiver in November of 2014, and process was set-in motion for the straight sale of the property.

Superintendent Melissa Moore, who took over the position last summer, said that one of her priorities when taking the job with the District was to "reach a resolution" regarding the Imperial property. She noted that she had researched possible options, including a ground-lease, but came to the conclusion that the lease option did not seem to be as lucrative as the straight-sale option.

Said Moore: "The Board has really explored all of the options, performed more than there

due diligence. They really took the time to deliberate and come to the conclusion that this is in the best interests of the students of the ESUSD."

Perspective bidders were required to submit their bid proposal, along with a \$10,000 bid security, in writing to the District by 3 p.m. on Tuesday. A bid hearing took place at 4 p.m. Interested parties who had not submitted a written bid were allowed to make an oral presentation at that time. Four written bids
